Cancellation Policy: You may cancel your participation with the St. Mary's Center team for the Rodman Ride for Kids waiving your responsibility for the \$1,500 minimum anytime on or before July 23, 2017. **You must notify the Development Department of St. Mary's Center in writing on or before the cancellation date.** Your \$50 deposit fee is non-refundable. After July 23, 2017, you are responsible for raising the \$1,500 minimum, even if for any reason, including injury, you are unable to participate in the Rodman Ride for Kids.

Please note that should you not participate or complete the Ride, any donations raised and received by our office will not be refunded, including your deposit fee.

Matching Gift Policy: Many companies match employees' charitable contributions. You can check with your employer to see if your company has this program, and ask donors if their employers match gifts. Many companies issue matching gift checks quarterly or semi-annually: therefore, if you plan to use a match to reach your minimum, it is your responsibility to contact the matching company to ensure the check will be issued before October 1, 2017. If the companies match cycle is past October 1, the match will not be matched by the Rodman Ride.
